



Solicitor Apprenticeship

If you don't feel like University is for you and/ or you would like to avoid student debt but, know that you want a career in Law, a Solicitor Apprenticeship is the way to go. You'll be working, earning and studying all whilst training to become a fully qualified solicitor.

Providing that you have sufficient A-Levels, you can apply for this 6-Year qualification that ends in you becoming a fully qualified solicitor.

During the course of the Apprenticeship we will give you one day off a week for study leave. Your first 4 years will be spent completing an LLB in Legal Practice and in years 5 and 6 you'll be studying to undertake the SQE1 & 2 exams. During this time you'll spend time in at least 3 different training seats whilst completing your 2 years Qualifying Work Experience. Depending on business need, your seats will be in one of our practice areas which comprise of Conveyancing, Civil Litigation, Personal Injury/Clinical Negligence, Family, Business and Wills & Probate.

Main responsibilities will include: drafting documents, conducting factual and legal research, attending client meetings, assisting with the opening, running/progressing and closing of files, reviewing documents, liaising with clients and other parties, and generally assisting your supervisor with various legal tasks.

Throughout your Apprenticeship you'll receive regular training and support from your supervisor and buddy/mentor along with a personal tutor from the University of Law, who will give you guidance with your course and meet with you throughout the programme to keep up to date with your progress.

Applicants will be interviewed in May with the successful candidate(s) starting the Apprenticeship in September 2023.
